The great thing about this club though, is that its members are only too happy to teach and show you things about your car. Believe me when I say this is an EXCELLENT opportunity to get under your car and learn about it, even if you don't want to care to ever work on it yourself.

I'm also in talks with a local company to see if we can work out a deal to have a portable dyno available, and this will all depend on the cost and how many folks are interested in using it. A dynamometer is a device that basically determines your car's horsepower and torque. It produces a graph showing your RPM range and the amount of torque and HP as you accelerate, and helps in everything from learning where you should be shifting gears, issues your engine may be having, to getting information on how all those expensive modifications to your car are actually paying off.

Since we're having the shop night on the 28th of September, we are canceling the normal General Business Meeting held on the 4th Tuesday of September. Additionally, since the SpookTacular weekend is just a few days from that date, those folks who are racing that want to "pre-tech" their cars can do so. just wanted to let everyone in the club know that the October 27th charity run that the NVCC is supporting is fast approaching! Here are the detail for those of you that might not know about this event.

On Thursday, October 27th at the Worldgate Sport & Health facility in Herndon I (George Kerns) will be representing the NVCC in a charity run to raise \$100,000.00 for the "Joe Gibbs" Youth for Tomorrow" foundation, and Project Fit America. This event without a doubt will be the largest fundraiser that NVCC has ever done, and probably one of the largest in the country for any Corvette club. I personally will be running 50 + miles in an 8 hour period on a treadmill to raise these funds. That is where you as the club members come in. I would like to see I

everyone in the club get involved with this effort to make our club shine above all others. I need you (All club members to go out and get pledges for this event) to make this a successful event.

I have been training diligently for the last 5 months for this event, and I WILL succeed at reaching my goal of 50 miles. I have also been working on several sponsors to host, and help out with this event. Sport & Health Clubs, Metro Run & Walk, and Tri-nergy have all jumped on board to pitch in to help in any way they can. Two of which have even offered to help out on the day of the event so that they can be personally involved.

This event IS going to be covered by several media sources so it will be great exposure for the club also. I will go more into details on the media at the next GBM this month along with all the other final details for this event. The pledge sheet is in the newsletter. We will have until NLT the October 25th GBM to tally up all pledges so that we can present a ceremonial check to the charities after completion of the run.

With a club like ours this is a VERY, VERY obtainable goal! I have found that these are two great organizations to work with, and people are very responsive to them. In the last day or two I was just getting people's opinions on the flyer I made up, and have already received over \$2,500.00 in pledges without even starting to solicit for pledges yet! That is all in donations of \$20 - \$100 each. I have also found that there are companies out there that have matching funds when people make donations also. That adds up very quick. To prevent sticker shock what I have been doing is telling people that they can either pay now or after I complete the run. Most are choosing the later of the two, and making larger donations. Most people are amazed that there is an idiot dumb enough to run 50 miles to raise funds, and are glad to help out!

There will be receipts for people as all donations are tax deductible. For anyone that knows any companies that would like to sponsor, and receive exposure, a donation of \$500 or more will get them on the banner I'm working on for the day of the event plus I'm working on a spot for them to advertise also so they WILL get exposure. As an added incentive I am working on something nice for the person that collect the most money in pledges, and if you bring any business sponsorships in, it will count towards your pledges! The gift has yet to be determined, but I will announce it at the next GBM.

As you all can see, I am taking this run serious. My Grandmother was a temporary foster parent for Fairfax county for 31 years, and raised over 1,500 teenage boys in her home! She used to tell me that we need to take care of our youth because there is going to be a day that we need them to take care of us. How true that statement is! This is a great opportunity for the club to show our community that we do care, and we are not just a bunch of Corvette owners going through a midlife crisis like I heard on the radio the other day!

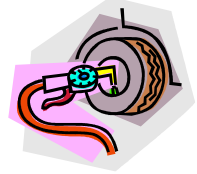

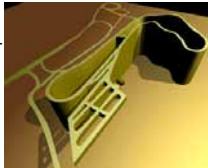
